

LiFeBlue Battery Limited Warranty

LiFeBlue Battery (hereafter LiFeBlue) warrants each LiFeBlue branded Lithium Ion battery sold by LiFeBlue or any authorized dealers or distributors, to be free of defects from the date of purchase subject to the terms and conditions listed below.

Warranty Period

LiFeBlue will will repair or replace the battery or parts of the battery if determined by us to be defective in materials or workmanship,

- A) From the date of purchase for 60 months, OR
- B) For 60 months to 120 months after the date of purchase, if the battery is reasonably repairable as determined by us. If it is determined to be unrepairable by us, LiFeBlue will offer you a new, similar replacement battery discounted by 40% off the concurrent price listed on the LiFeBlue website. The replacement offer will be sent by email, text or in writing and will only be valid for 30 days after our determination is made.

Non-Transferable

This Limited Warranty is extended to the Buyer as the original purchaser of the Product and is not transferable to any other person or entity. Proof of purchase may be required for warranty claims.

Application and Use

LiFeBlue batteries are designed to be used as deep cycle batteries. Batteries may be used for off grid energy storage, recreational vehicles, boats and marine uses, industrial or other deep cycle applications. LiFeBlue batteries are not designed for primary engine starting but may be used to supplement engine starting.

Warranty Exclusions

LiFeBlue has no obligation to provide warranty for any product subjected but not limited to the conditions listed below.

1. LiFeBlue is not obligated to warranty a battery if failure is related to damages caused by abuse or negligence, tampering, non-adherence to LiFeBlue guidelines or from any of the following: a) Damage from shipping, b) Loose terminal bolts, c) Corroded hardware, d) Failure to properly install and connect the battery, e) Failure to properly charge and maintain the battery, f) Breakage or damage from collision, fire, freezing, damage from extreme heat or cold, improper storage, reverse polarity connection, short circuit of the battery terminals or water damage.
2. Shipping cost to and from LiFeBlue repair facility is not covered by this warranty. The buyer will be invoiced and must make payment for shipping prior to LiFeBlue returning the battery.
3. If within 30 days of the purchase date you have a warranty claim, shipping cost to and from LiFeBlue repair facility will be paid for any address within the 48 contiguous states.
4. LiFeBlue is not responsible for dealer or distributor created or implied warranties or any claims that may arise from said warranties.

Warranty Procedure:

For Warranty Claims contact LiFeBlue at the email address or telephone number below with the details of your claim. LiFeBlue will make the arrangements for battery shipment to our service facility to assess the battery. We will determine the cause of failure and contact you.

If the failure is determined by us to be covered under the provisions of this Warranty, it will be repaired and returned to you.
